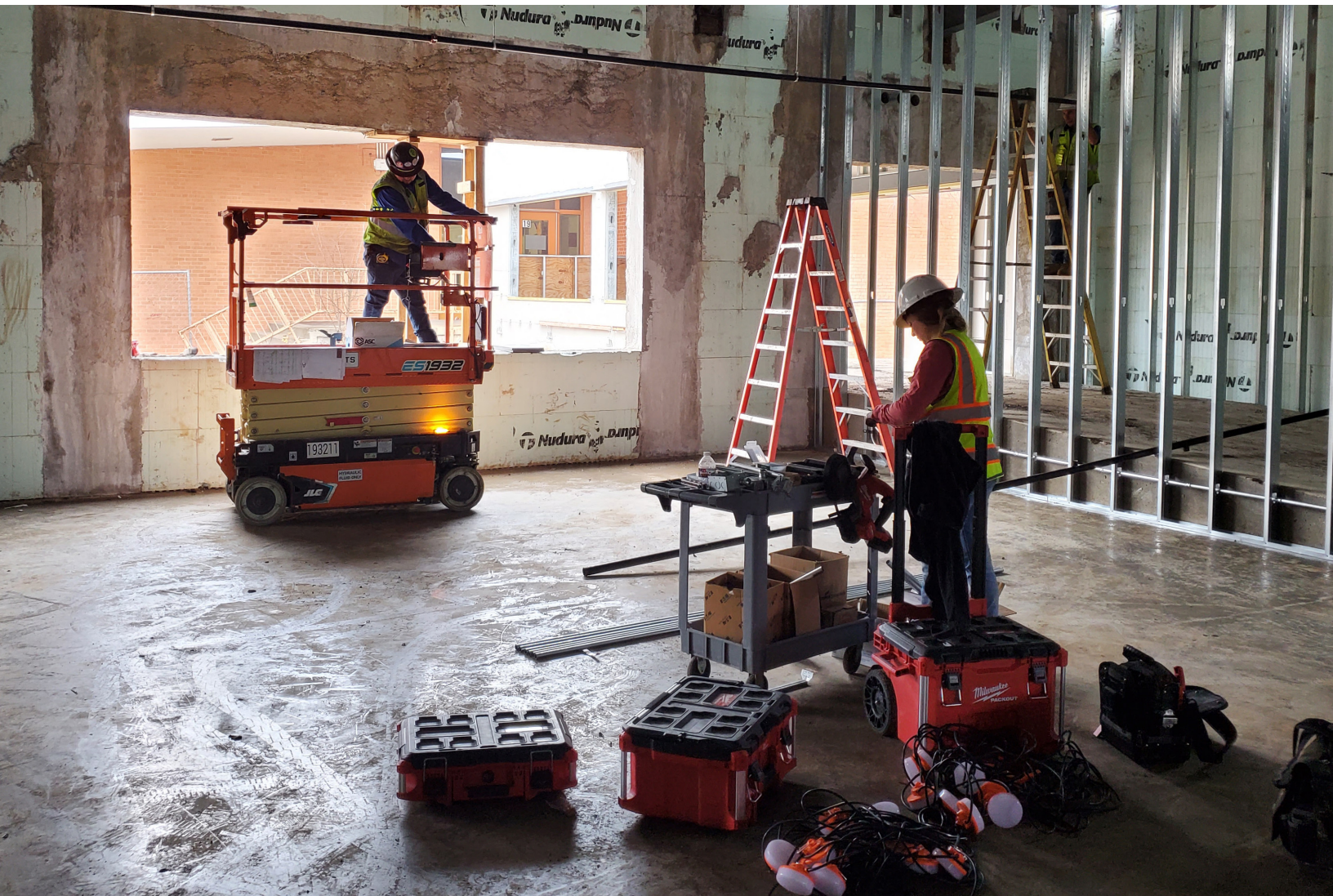

MetroCare is Dallas County's largest provider of behavioral health and developmental disabilities services. Source Building Group is serving as Construction Manager at Risk (CMAR) for this project which consists of expanding the facilities by redeveloping its current ten-acre campus. It adds a new one-story 45,300 square feet clinic that will include behavioral health service departments for patients of all ages. The redevelopment project will also include a new 258,700 square feet client services building comprised of two levels of Class A administrative office space, a commercial kitchen and wellness center above a mixed-use podium that will include parking garage and some additional complimentary client services.

The Clinic Building will be designed to achieve LEED Gold Certification and the Client Services Building is designed to achieve LEED Platinum Certification. Photovoltaic panels, electric car charging stations daylighting and energy-efficient glazing are some of the key sustainable features incorporated into this project.

Source Building Group, Inc. serves as a CMAR Partner for this project that consists of three buildings (five-story 349,158 square feet adult services, four-story 285,265 square feet children services, and a 686-space parking garage). The primary activities within the new facility are eight inpatient units (one med psych, one dual diagnosis, one forensic, two mood disorder, three psychotic), unit occupational therapy and rehab programs, administrative spaces, as well as dining and living spaces. Shared between all inpatient units are adjunctive therapy programs and spaces including multipurpose therapy supporting music therapy, art therapy, gardening (horticulture), physical education, shared community dining space, shared outdoor gardens/courtyards, chapel, and life skills therapy.

A portion of this classroom building will be constructed as 5,555 square foot tornado storm shelter. The renovation work is for limited areas that include the existing school offices, school nurse area and classroom areas to bring to new school district standards specifications. This includes items such as material finishes, millwork, and other miscellaneous items. Renovation also includes updated work to selective mechanical, electrical, plumbing, and special systems. There is new site work on school campus relative to new building addition areas, new grading, new and modified accessible walkways, ADA ramps between existing and new building, new playground with relocation of existing playground equipment and two canopy frames complete. 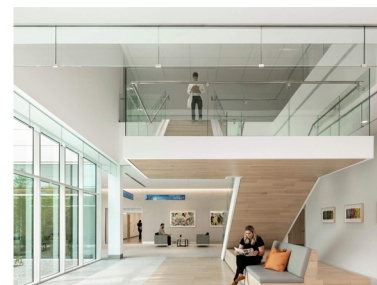

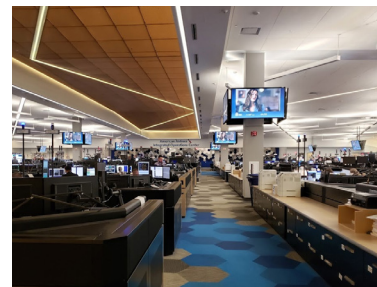
